ÉCOLE HERITAGE PARK MIDDLE SCHOOL CODE OF CONDUCT

Purpose:

- To maintain a safe, caring, and respectful environment for learning.
- To establish and maintain an appropriate balance among individual and collective rights, freedoms, and responsibilities.
- To clarify expectations for student behaviour while at school, while going to and from school, and while attending any school function or activity at any location.

Reference to the BC Human Rights Code:

École Heritage Park Middle School promotes the values articulated in the BC Human Rights Code, respecting the rights of all individuals in accordance with the law. Discrimination is prohibited based on race, colour, ancestry, place of origin, religion, marital status, physical or mental disability, political belief, sex or sexual orientation – in respect of discriminatory publication and discrimination in accommodation, service and facility in the school environment.

Conduct Expectations:

1. Treat yourself and others with RESPECT
2. Demonstrate RESPONSIBILITY
3. Ensure the SAFETY of yourself and others by making wise choices

*These expectations are outlined further on page 8 as part of the S.O.L.E.S. section.

Acceptable Conduct:

- Be respectful to yourself, others, the environment and property
- Be helpful to others by thinking and playing safe
- Report to an adult if you think someone needs help
- Recognizing the impact of your actions before you act
- Take pride in your accomplishments and strive for your personal best
- Avoid situations where you may be assumed to be guilty by association

Unacceptable Conduct:

These behaviours are examples only and are not an all-inclusive list. Unacceptable behaviours are ones that:

- interfere with learning
- interfere with the respectful environment
- create unsafe conditions
- involve name calling or inappropriate language
- involve bullying, harassment, intimidation or defamation

- involve physical violence
- involve retaliation against a person who has reported incidents

As students mature, we expect increasing personal responsibility and understanding of how actions effect the environment, community and self.

Consequences:

Where responsive measures are required, a variety of factors will be considered, including: the age and development level of the student, the severity and frequency of the incident, disability, cultural responsiveness, context and impact.

- Responses will be equitable and free from bias.
- Responses may involve restorative practices.
- Students will be invited and supported to participate in the development of meaningful consequences and restitution.
- Responses may include: verbal teachings, student reflection outside of class time, restitution, confiscation of items with a shared understanding of the harmful effects on self and others, additional supervision, referrals to addictions services, counseling and community support services, suspension.
- If student conduct poses a threat to the safety of others, a suspension may be necessary to organize a safe return to classes for the learner.

Notification:

Our school personnel will advise other parties of serious breaches of the code of conduct. For example, parents of student (s) involved, school district officials, as required by law, and others, when deemed to be important to reassure members of the school community that school officials are aware of a serious situation or incident and are taking appropriate action to address it.

Closed Campus: École Heritage Park Middle School is a CLOSED CAMPUS. This means that only students who attend École Heritage Park Middle School are to be on the school grounds during the school day. **It also means that once students arrive at school, they are to remain on the school grounds for the rest of the school day, lunch included.** **Students are not permitted to cross the street to the Heritage Park Plaza at any time during school hours. Food delivery services are not permitted (ie. Door Dash, Skip...).**

Visitors: All visitors are required to report to the office upon arrival. Parents dropping off lunches, homework, planners, etc. for their child are asked to leave items at the office, and we will page your child during breaks between classes.

Absences: Parents or guardians are requested to email the school (hpms.info@mpsd.ca) by **9:00 am** to report a student's absence or lateness if they are excused.

Sign In and Out: Any time students are late they must sign in at the office and get a late slip to give to their teacher. Students who need to leave early for an appointment, must sign out at the office and sign back in again when they return. A note or a phone call from a parent to accompany this is mandatory.

Illness or Injury at School: Students who feel sick or become injured at school need to inform their teacher and report to the office, where they will be advised about calling parents or guardians. Students will be sent to the medical room until such time as they either return to class or their parent/guardian arrives to take them home. For serious injuries, an ambulance will be called, and parents will be contacted as soon as possible.

Contact Information: For unexcused absences a call will be placed with the school auto-dialer. In the event of sudden illness or injury, parents will

be called. Parents are asked to provide the school with up-to-date contact information.

Cash Free: École Heritage Park Middle School is a cash free school. Payments can be made through School Cash to pay for field trips, student fees, yearbook, cafeteria, and Thistle Stop cards. Point of Sale machines, accepting debit, will be available at the Cafeteria and Thistle Stop starting the second week of school.

School Cafeteria & Lunch Routine: The lunch break is 41 minutes long. Students may bring their own lunches from home, or order lunch from the cafeteria by either purchasing a cafeteria card online (\$5, \$10 or \$20 cards) or bringing a debit card (no cash). *Students should bring a lunch from home the first week of school, pizza will be sold in limited quantities.* All profits go back into the school to pay for various learning resources and school programs.

Thistle Stop – School Store: The school store is open at lunchtime. Thistle Stop cards can be purchased online in \$5 increments, debit will also be accepted. Snacks and school merchandise are available for purchase. All profits go back into the school to pay for various learning resources and school programs.

Student Services: The student services team is a team of administrators, teachers, counsellors, and support workers, who provide a range of supports and programs designed to meet the academic, social, emotional, behavioral, and physical needs of students. These services are intended to ensure that all students can access learning opportunities and succeed in a safe, inclusive, and supportive environment. The inclusionary model integrates students into grade appropriate classes and individual needs are met within the classroom environment as much as possible by classroom teachers, in conjunction with support from the student services team.

Athletics and Clubs: Clubs and teams are an important part of student life at Heritage Park Middle School. The athletic teams for our school will be coached by teachers and parent volunteers. We will offer intramural programs during our lunch break, where students can play with and against their friends and meet other students. During our intramurals students can develop their skills in many sports. Our extra-curricular programs, where we play against other middle schools may include: Volleyball, Basketball, Football, and Track and Field among other sports. We also hope to offer a wide range of clubs including, Library, Computers, Games, and Drag Racing Club.

School Planners: School planners are available with the purchased Highlander Package. The school planner has been designed to help students manage time and plan their day. All students are encouraged to keep their planner up to date throughout the year. When teachers assign homework and tests, it is expected that students record the nature of the

homework or test in their planners. By recording homework and tests all students will be aware of what each teacher expects and when assignments are due.

School APP: Stay informed and up to date on school events and news by downloading the **My School Day App**. Notifications can be sent instantly from the school using the app. This way students and parents can be quickly informed and reminded of changes in schedules or coming events. The app is also customizable using colors and labelling to identify classes. *The My School App can be downloaded from iTunes and Google Play app stores onto cell phones or tablets.*

School Fees: Fees are to be paid online using School Cash at <https://mpsd.schoolcashionline.com>. The fees outlined below are necessary to support school programs offered to all students. (Athletic fees are *only* required if your child joins an athletic team).

Parent Advisory Council: The Parent Advisory Council (PAC) is your parent community at Heritage Park Middle. Every parent is automatically a PAC member. PAC executive members are elected at the PAC meeting in September each year. Our PAC meets once per month. See the school website for a schedule. It is hoped that our parent community will work closely with administration and staff to support, encourage, and provide assistance to enhance the quality of education and the well-being for all students at Heritage Park Middle.

School Communication: While many factors affect a child's education, there is one that can be of paramount importance - communication. Frequent and open communication between parents and teachers leads to a greater understanding and appreciation of the educational process, as well as each child's participation in it. We welcome and appreciate your inquiries and visits, and encourage you to contact us when, and if, concerns or questions arise. If you have a concern, we ask that you contact your child's teacher first via email or phone message. If you wish to meet in person with a teacher, please schedule an appointment in advance. If you feel your concern has not been addressed by the teacher, please contact one of the school administrators. If your concern has not been addressed, you may contact the School Board Office at 604.826.6286.

How Can Parents Help? Learning is not confined to the classroom. Parents are vital partners in the educational process. Some ways in which parents might help are:

- Ask your child what the best part of their day was. Why?
- Help your child set aside a time and place to study.
- Be supportive by offering lots of praise and encouragement.
- Limit screen time and promote physical activity.
- Keep in touch with the classroom teacher as to the classroom routines, expectations, projects, etc.

Physical Activity: At Heritage Park Middle, we encourage students to be physically active while at school. Research has indicated that:

- Physical activity has a positive effect upon children's academic achievement, academic readiness, and perceptual skills.
- Regular physical activity improves children's mental health and contributes to their growth and development.
- Physical activity is consistently related to improved self-esteem and body image.
- Adolescents who engage regularly in physical activity demonstrate lower anxiety and depression.
- The prevalence of childhood obesity is increasing - this is directly linked to a lack of physical activity.
- Participation in physical activity is positively linked to aerobic fitness, body composition, and muscular strength among school children.
- Participation in regular physical activity has a positive impact on behaviour and healthy lifestyles in youth.

- Middle school students, who are physically active, are less likely to consume alcohol, smoke, use marijuana, or engage in sexual behaviours when compared to inactive peers.

B. Student Responsibilities

Attendance, Class Assignments and Homework: Attending regularly and putting effort into learning are the prime responsibilities for students. This includes being in class on time, with the required materials, participating in class activities and completing assignments, including homework. Middle school students should be doing anywhere from 60 to 90 minutes of homework each day. However, we need to keep in mind that students need a balance between work and play. If parents believe excessive amounts of homework are being done by their child, please contact your child's teacher.

Consequences for not attending and/or not completing assignments:

- staying in at lunch or after school to complete work
- lower grades
- parent/student/teacher conference to develop a plan for improvement.
- referral to the office
- Insufficient Evidence of Learning notice (a notice to parents indicating that a student may be about to receive a failing grade in a particular subject unless the student completes specific assignments within a specific timeline, as outlined in the notice.)
- failing grades
- becoming involved in at-risk behavior (during unexcused absences)

Consequences for attending regularly and completing assigned work:

- sense of personal satisfaction of having done a job well
- positive self esteem
- positive recognition from teachers, peers, parents
- positive comments and grades on report cards
- **most importantly, these students can expect to show good growth in learning and achievement.**

Copying & Plagiarism: Students are expected to present their own work in their own words. The substitution of work copied or taken from other students or from other sources such as the Internet, and presented as their own, is not acceptable and will result in appropriate consequences.

Computers, Computer Labs and Materials: A high level of maturity and honesty is expected of students as they use school computers and computer labs, electronic media, and materials. Students are held accountable for computer use and for media in their area of responsibility. This includes:

- No food or drinks allowed in any computer lab.
- Students are not to use school computers without direct staff supervision, especially when using the Internet. Students must seek permission to access the Internet on every occasion.
- Internet access from the school is only for the purpose of a direct educational need. Internet access from the school is only available and is only allowed for assigned projects for courses.
- Internet access from the school is denied to any student who has not completed, with their parent or guardian, the Student Internet Access Agreement Form.
- Your computer password is private and privileged. Sharing of passwords is in violation of school policy.
- The theft or use of unauthorized or restricted access materials in the school's network servers obtained by accident or hacking, is not permitted.
- Materials involving pornography, vulgar language, racially bigoted and insulting or defamatory comments, are not permitted.
- Students are not allowed to access personal e-mail accounts through school computers.

Lockers: Lockers are the property of the school, and the contents are subject to school supervision. It is a privilege to have a locker. It is the students' responsibility to take care of their locker and to ensure that their lock combination is kept secret. Students are not to mark up the doors of lockers. Use a magnet or fun tack to hang a poster; do not use tape or glue. Everything put on a locker must be removable and show no marks! All decorations must be in good taste! Students may not switch lockers to be closer to a friend. Students may only go to their lockers during non-instructional times. Anything that is unsafe or could be dangerous to others should never come to school and must never be put in a school locker. Locks are supplied by the school. **Only school issued locks are to be used on school lockers.** There is a \$10 charge to replace a lock.

Classroom Behaviour: Teachers set classroom behavior expectations. Minor infractions at the classroom level are dealt with by teachers. Major infractions are referred to the office. All classroom behavior must be consistent with our school code of conduct.

Bathroom & Hallway Behaviour: Behaviour and language should be suitable to a place of learning and reflect the S.O.L.E.S Code of Conduct (see page 8). There should be no profanity or inappropriate remarks or touching of others. Public displays of affection in the school setting are not appropriate. Play fighting is not allowed. Filming of others is not permitted.

Behaviour and Teacher, Teaching-On-Call: It is business as usual when a teacher is absent, and a teacher teaching-on-call is required. Students are expected to give this teacher the same courtesy and cooperation that is observed with their subject teacher.

School Functions: Students attending a school function, even when away from school, are expected to demonstrate responsible behaviour and to follow all school rules. School functions include dances, athletic events, field trips, and concerts.

Dress Code: The school District supports individual choice in clothing for students, emphasizing safety and respect. Student clothing guidelines for individual schools must be gender neutral, and stress:

1. A students' right to individual choice, safety, and respect - for self and others.
2. That clothing worn must be safe and suitable for students to participate in activities such as physical health education, science experiments, fine arts, and/or applied skills as necessary.
3. That hats, headwear, and clothing worn should demonstrate a respect for the school community and meet standards of suitability that are typical of a K-12 Educational Facility. At HPMS we ask that hoodies, and sunglasses are not to be worn inside the school.
4. That students must not wear clothing:
 - 4.1. That compromises a safe and inclusive learning environment; Examples include: language or images that are threatening
 - 4.2. That promotes the use of tobacco, marijuana, illegal drugs, or alcohol;
 - 4.3. That advocates illegal activity;
 - 4.4. That encourages sexism, racism, homophobia, or bigotry.
 - 4.5. That includes insignias, symbols or adornments that denigrate or promote hatred of a person or persons, including, but not limited to, clothing that denigrates or promotes hate based on race, colour, ancestry, place of origin, religion, marital status, family status, physical or mental disability, sex, sexual orientation, gender identity and / or expression, or age;
 - 4.6. That bears direct or indirect messages or graphics referring to gang culture, sex, pornography, obscene images, weapons, or violence.
5. Other than for religious purposes, health and safety requirements, or where required to accommodate a disability, students must not wear clothing which obscures their face.

Allergies & Sensitivities: As a safety precaution, for all staff and students, we support a nut aware school environment. Please refrain from bringing nut products to school.

Scent Free Environment

Perfume, Cologne, Body Spray: Many staff and students have serious allergies and sensitivities to scented products. We strive to provide a healthy and safe environment for all. Many classrooms and school areas are designated "**scent free**" and we require that those entering these areas refrain from using strong smelling perfume, cologne, deodorant, body spray or similar products.

Bikes, Electronic and Push Scooters: Bikes and scooters must be walked upon arrival at school and parked in the bike racks. Bike locks are recommended. Students are not permitted to be around the bike rack area during the school day. The school will not be responsible for any damages to bikes or scooters brought to school.

Skateboards and Roller Blades: Skateboards and roller blades may not be used at school to ensure a safe environment is maintained.

Weapons (Real and Toy): Weapons are not permitted at school. Costumes for special days must not include weapons or items that resemble weapons.

Laser Pointers: Laser Pointers are not allowed at school. Some laser pointers can damage a person's vision if pointed directly in the eye.

Drugs and Alcohol: Students and adults are prohibited from bringing drugs or alcohol to and from school or being under the influence of drugs or alcohol while attending school or school sponsored activities.

Smoking: The provincial government prohibits smoking in or on school property.

E-Cigarettes/Vaping: E-Cigarettes/Vapes are not permitted at school. There are serious health concerns with inhaling e-cigarette/vape chemicals. There are also concerns that e-cigarette/vape use closely resembles smoking and may encourage students to try smoking. Mission Public Schools – Impairing, Banned, or Controlled Substances Policy will be enforced, and any vapes, or vaping products found on school property will be confiscated and disposed of. To ensure the safety and education of all students, vape detecting devices have been installed. The system is designed to immediately notify both school administration and district-level staff, allowing for a swift and appropriate response. Camera technology provides enhanced monitoring of individuals entering and exiting washroom areas. This will help identify possible individuals involved. School administration will follow up with those identified. Cameras are *not* installed inside any washroom.

Valuables: Students are strongly discouraged from bringing expensive valuables to school. Students should not bring large sums of money to school and should never leave money or valuables in the P.H.E. change rooms. If valuables are brought to school, they should be locked in the student's locker, thereby minimizing the temptation for theft. Valuable items are brought to school at the owner's risk; the school is not responsible for any loss.

Personal Digital Devices:

Per Ministry and District policy, École Heritage Park will implement the following policy:

- Middle School students are not permitted to have cell phones or other personal digital devices ('PDD') during school hours, including at lunch and other breaks. This includes areas outside of the building.
- Student PDD cannot be present until exiting the building after the end of the school day.
- Should a student be in possession of a device, it is expected it will be stored in a locker until after the last bell of the day.

Please note that some students may have a medical exemption for specific conditions – please contact your school if this is the case for your child.

The following procedure will be used for violations of these expectations:

- 1st issue - The student will be issued a warning by the teacher or staff member. We expect students to comply with this request without becoming argumentative or defiant. Students not complying with this request may be sent to the administration.
- 2nd issue - The PDD will be sent to the office and held by administration for the remainder of the school day.
- 3rd issue - The student will be sent to the office, and the student will hand in their device to the administration. A student's parent/guardian will be asked to pick up the device. A follow up meeting may be held.

'Personal Digital Devices' include, but are not limited to, cell phones, tablets, computers, smartwatches, Bluetooth equipment, and portable video game systems. Continuing to disregard these expectations may result in consequences per the Code of Conduct and may include in school suspension, out of school suspension, and/or other disciplinary consequences.

As with other valuable items, **the school will not be responsible for damage or theft of such devices.**

We understand that many parents/guardians use text messages to communicate with their children during the day. Please remember to communicate with your child before and after school, as they will not have access to their devices at other times. For emergency situations, we ask that you contact the school office, and we will pass along your message or have your child contact you.

We ask that you support our staff and discuss this change with your child. Thank you very much for your cooperation and support during this change. Working together we can make our schools the best places to learn they can be.
